Service commitment

- 1. - 2. The packing material, packing standard and packing method of the buyer are all in conformity with the safety requirements. There are any obvious damage to the packing in the process of transportation. The buyer has the right to refuse to sign the goods. Each packing unit is attached with a detailed packing list and quality certificate.
- 3. The supplier will fulfill the service promise in accordance with the relevant state laws and regulations and the "Three Guarantees", and provide after-sales service to purchasers. The warranty time of the goods is valid for 13 months from the date of signing the contract. The cost of the product is exempt from the quality of the product during the period of the period, and it will provide life-long maintenance at the cost and cost overdue.
- 4. When using, it does not infringe upon any third party's patent right, trademark right, industrial design right or other rights.

Settlement of contract disputes

- In case of disputes over the quality of the goods, the state authorized quality inspection institutions shall be invited to
 appraise the quality of the goods. If the goods are up to the standard, the appraisal fee shall be borne by the purchasers,
 and the appraisal fees shall be borne by the suppliers if the goods do not meet the standards.
- 2. In the event of fulfilling the disputes arising from or relating to this contract, the parties shall first settle the dispute through friendly negotiation. If the negotiation cannot be resolved, the lawsuit may be brought to the people's court with the jurisdiction of the supplier where the supplier is located.
